RE: BBX Holdings Limited (BBX) - Results of the Partial Selective Buy Back

As announced to the market on 22 December 2009, the Company undertook a partial share buyback which closed on 5 February 2010 (**Selective Buy Back**). All eligible shareholders under the Selective Buy Back (**Eligible Shareholders**) had four choices as a form of consideration under the Selective Buy Back. The four choices included the following:

- (a) Accept Cash: receive half a cent (\$0.005) per fully paid ordinary share in BBX Holdings Limited (BBX Share) held; or
- (b) Accept fully paid ordinary shares in BBX Property Investment Fund Limited (BBX PIF): receive one fully paid ordinary share in the BBX PIF for every seven BBX Shares held; or
- (c) Accept BBX Trade Dollars: receive one BBX Trade Dollar for every seven BBX Shares held (you needed to be a member of the BBX Trade Exchange to accept this form of consideration); or
- (d) Accept a combination: accept a combination of (a), (b) and (c) for BBX Shares held.
