### RE: BBX Holdings Limited (BBX) - Sale of Subsidiary Companies

As announced to the market previously, BBX Holdings Limited (the **Company or BBX**) conducted a review of its business. As a result of this review, it was considered that whilst the business was robust as a private operation, the opportunity to increase shareholder value by focusing on the development of the existing business was limited. Accordingly, the Company decided to conduct a restructure.

As an overview, the main items in the restructure proposal that the Board agreed (and which shareholders approved on 22 January 2010) were as follows:

- (C) BBX to buy back 90% of the shares held by each shareholder of the Company, other than various major Shareholders of the Company (Selective Buy Back);
- (b) BBX to sell the majority of the Company's assets and liabilities to Barter Bonus Points Pty Ltd (BBP) and www.ebbx.com Pty Ltd (EBBX), being entities associated with founding director, Mr Michael Touma (BBX Disposal). The Company was to retain the Sydney franchise of BBX subject to the terms of the franchise agreement with BBX Management Pty. Ltd; and
- (C) Michael Touma, Barry Dawes, Peter O'Mara (and each of their associated/related entities) and <a href="https://www.ebbx.com">www.ebbx.com</a> Pty Ltd to sell its shareholding in the Company, being 35,276,996 fully paid ordinary shares in the Company to the Arthur Phillip Group (as that term is defined in the Company's Notice of Meeting dated 11 December 2009) (Arthur Phillip Acquisition).

Further details of each of the above steps are provided below.

### **Selective Buy Back**

On 12 February 2010, following Shareholder approval being obtained on 22 January 2010, the Company bought back the 8,770,320 shares the subject of the buy back and these shares were automatically cancelled on this day (section 257H(3) of the Corporations Act).

Please find attached to this announcement a Form 484 notifying ASIC of the cancellation of 8,770,320 Shares in the Company.

The overall effect on the capital of the Company of the Selective Buy Back, is as follows:

### **BBX Disposal and Arthur Phillip Acquisition**

Completion of the Disposal and the Arthur Phillip Acquisition occurred on 1 March 2010. As a result of completion of the Disposal and the Arthur Phillip Acquisition, BBP now owns the majority of the Company's assets and liabilities with the exception of the Sydney Franchise and the Arthur Phillip Group has a voting power in the Company of 55.96% (please refer to the Form 603 lodged earlier today).

As the above transactions have now been completed, the Company will now look for additional business opportunities whilst retaining an interest in the Sydney Franchise.
