### **Trading Halt Request**

Pursuant to ASX Listing Rule 17.1, BBX Minerals Limited (the **Company**) (ASX Code: **BBX**) requests an immediate trading halt be placed on its securities, pending a response to an ASX price and volume query.

In accordance with Listing Rule 17.1, the Company advises:

- a) The Company intends to make an announcement in response to an ASX price and volume query dated 18 September 2020;
- b) The trading halt is to last until the earlier of the Company releasing the announcement regarding the response or the commencement of trade on Tuesday, 22 September 2020. We expect that the trading halt will be ended by the Company making an announcement of the kind referred to above; and
- c) the Company is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.

BBX Minerals Limited is a mineral exploration and technology company listed on the Australian Securities Exchange. Its major focus is Brazil, mainly in the southern Amazon, a region BBX believes is vastly underexplored with high potential for the discovery of world class gold and precious metal deposits.

BBX's key assets are the Juma East, Três Estados and Ema Gold Projects in the Apuí region, Amazonas State.
